APPLICATION TO CHANGE THE LEVEL OF FLOOD PROTECTION

WITHIN A WATERSHED

The Council of the City of North Bay has directed the administration to seek your approval to reduce the level of the flood protection on Chippewa Creek, Parks Creek and the La Vase River to the minimum of 1:100 year standard. Attached please find Planning and Development Report No. 8-85, passed by the City of North Bay on August 19, 1985.

The City of North Bay makes this request so that equitableness can be retained in the development control process while new flood plain policies are brought into effect. As you may be aware, the existing level of flood protection affects a significant portion of the urban area of North Bay, especially in the West Ferris area. We,in conjunction with the North Bay-Mattawa Conservation Authority, have investigated all reasonable options of integrating flood plain controls with municipal growth and development strategies.

The lowering of the flood standard in a portion of North Bay is only one part of a complex management package which includes an Official Plan Amendment to establish strict environmental protection policies in North Bay, an amendment to the City of North Bay Comprehensive Zoning By-law to place land use restrictions on flood prone lands, a Site Plan Control Area affecting all those areas impacted, a commitment to remedial works which will protect existing development from flooding, and the control of construction and filling within the flood plain areas through regulation by the Conservation Authority. This request is supported by the necessary technical information available from the Conservation Authority.

We have met the procedural requirements for applying for a reduction in the level of flood protection established by your ministry (supporting information attached).



Natural Resources Ministry Announces Change to Flood Standard in Nipissing District

A change in the regulatory flood standard for Chippewa Parks Creek and La Vase River in Creek. jurisdiction of the North Bay-Mattawa Conservation Authority was announced today by Natural Resources Minister Vincent G. Kerrio.

The flood standard is changed from the Timmins Storm to the 100 year flood.

change was made in response to a request by the City of North Bay and supported by the East Ferris Township, the Minister said.

Even though the flood standard is reduced, the basic concept of flood plain management remains unchanged; that is ensuring that new development is not flood susceptible and that problems are not created or aggravated for existing development, he said.

CHANGE TO FLOOD STANDARDS

The City of North Bay in co-operation with the North Bay-Mattawa Conservation Authority have received approval from the Minister of Natural Resources, the Honourable Vincent G. Kerrio, to change the regulatory flood standard for the watersheds of Chippewa Creek, Parks Creek and the La Vase River. The change, effective February 23rd, 1987, alters the regulatory standard from the Timmins Storm to the 100 year flood.

This lowering of the flood standard in no way degrades flood plain management within the City of North Bay. change is only part of a complex management package which integrates flood plain controls with municipal growth and In addition to the change in the development strategies. includes standard. the management package following: a) Official Plan Amendment - to establish strict environmental protection policies in North Bay; b) Amendment to the City of North Bay Comprehensive Zoning By-laws to place land use restrictions on flood prone lands; c) Site Plan Control Area - affecting all those areas impacted; d) A commitment to remedial works which will protect existing development from flooding; e) Control of construction and filling within the flood plain areas through the North Bay-Conservation Authority Fill. Construction Alteration to Waterways Regulations.

Prior to selecting this package, all reasonable options were investigated using available technical information and public input. In applying for the reduction in the level of flood protection the procedural requirements established by the Ministry of Natural Resources were met.
